


Friends of the St. Clair River 2021 Annual Report

It was our theme when we moved out of our first home on the Blue Water River Walk in 2019, and it became our theme once again in 2021 when we opened the Thumb Coast Watershed Center. This year we more than doubled our staff, opened the region's first watershed center, and stayed connected to local issues like the St. Clair River Enbridge Line 5 replacement. Our Volunteers Make A Difference

300 volunteers | 1,779 hours of work | \$50,000 value

Our volunteers are active and committed, and regularly give of their time and talents for parks and trails throughout our watershed. Their hands-on work included native plant restoration, invasive species management, butterfly monitoring, and leading youth field trips. Since 2015, our volunteers have served over 14,500 hours of hands-on work!

Invasive Species Challenge

Our volunteers amassed 170 hours pulling 1,225 pounds of Garlic Mustard and other invasive species through the Stewardship Network's annual spring challenge. For this effort, we were able to declare Fort Gratiot County Park a Garlic **Mustard-Free Zone!**

Sanborn Park Ecological Survey

A dozen volunteers mapped and measured the ages of over 60 mature trees in Port Huron's Sanborn Park. The data volunteers and staff are providing helps protect trees, identify rare plant and wildlife species, and avoid damage to habitats during future trail work. This information will be used to guide education programs and restoration actions in the park.

Shoreline Inspection Paddle

Volunteers took to the St. Clair River in their kayaks to survey Port Huron's Blue Water River Walk shoreline to document the impacts due to record-high water levels, flooding, and erosion. Their photographs and investigation results are used to assess how the St. Clair River shoreline is changing over time and will inform recommendations for habitat improvements and trail repairs.

Butterfly Monitoring

Butterflies are a useful indicator of a healthy environment. By identifying butterflies and learning about their populations, volunteers are able to gauge the health of their habitat. As a result of the data collected we added thousands of Common Milkweed seeds and plants to local projects to improve habitat for monarch caterpillars.





Spongy Moth Suppression Program

The Blue Water Area faced a severe Spongy Moth outbreak in 2021, which led to St. Clair County partnering with us to revive it's suppression program of this invasive insect. We received over 800 infestation reports and developed a variety of educational resources and field training for homeowners and communities. Our staff and volunteers completed more than 450 property surveys covering 5,180 acres to gather data for the 2022 aerial spray treatment.

Bridge To Bay Trail

We championed progress of the Bridge To Bay Trail by overseeing \$4.5M secured for nine new trail segments, creating new trail kiosks and signage, and launching a new trail website. The Trail received a face lift in the Blue Water River Walk tunnel and new directional stencils. Trails provide exceptional recreational experiences that reconnect residents to natural resources and lay the foundation to foster a stewardship ethic.





Chronolog Photo Stations 3 stations | 90 photos

We installed photo stations at three parks for visitors to help us document the dynamic changes of the landscape. When visitors place their phone in the holder and snap a photo, a time-lapse video is built revealing the environmental change happening before them. The crowd-sourced time-lapse videos allows us to us to monitor invasive species, fluctuating water levels, and wildlife migration.

St. Clair River Drinking Water Survey 420 responses | 67% rated water as good 90% are concerned about contaminants Our survey assessed perception of the St. Clair River to rebuild trust in our drinking water. While most residents know their drinking water comes from the St. Clair River, most do not understand how water gets to the tap and what the water treatment process involves. Progress to restore and protect the St. Clair River is ongoing, including the reduction of spills to the river. The continued actions of many groups are contributing to St. Clair River improvements.



Environmental Education: K-12 Classrooms and Beyond

We continued to provide education programs online and in-person, which enabled our outreach to grow. Environmental education provides opportunities for students to become engaged in real-world issues that transcend classroom walls and take action to improve the environment. Preparing students to be good environmental citizens is some of the most important work we do.

Lake Sturgeon Outreach We engaged hundreds

of 5th graders in our free Sturgeon Science School, created a calendar with

students' winning sturgeon stories, and adopted out dozens of Lake Sturgeon that are tracked around the Great Lakes. Our Lake Sturgeon adoption kit provides informative, engaging sturgeon facts along with updates about their fish from biologists conducting research in the watershed.

Stream Leaders

This program empowers community members to protect local streams and rivers in a hands-on way by monitoring water quality. We train participants how to care for and protect streams. The small animals that live at the bottom of streams, like snails, mussels, and insects, are useful signs of clean water because these organisms vary in sensitivity to polluted water.

May The Course Be With You

We led volunteers for 18 workdays to prepare Columbus County Park for a 9-hole Disc Golf Course. Our volunteers added 263 hours of work valued at \$7,153 to the project by clearing brush, removing invasive species, identifying areas of high ecological value, and recommending actions for future invasive species control. **Growing Nature** We trained 20 volunteers to grow over 90 species of Michigan native plants from seed. Collecting and saving of these seeds is crucial to the continued restoration of parks. Seeds were harvested, dried and stored, and then were cleaned for use in 2022

restoration projects.
